

Schedule A - Electric Distribution Company Charges

For comparison to your supplier's electric supply service price, the tables below include The Connecticut Light and Power Company d/b/a Eversource Energy ("Eversource") and The United Illuminating Company's ("UI") Standard Service supply rates that you do not pay by enrolling with your supplier.
